## Call to Order

Kevan called the regular meeting to order at 4:30 p.m.

## Public Comment

None.

## Consent Agenda

Judy moved to approve the consent agenda; David seconded. All in favor; motion carried.

## Director's Report

Brad said he has attended several trainings since the last meeting. He and Kathleen attended Your Leadership Edge training from the Kansas Leadership Center. He also attended the NEKLS Director's Institute, a day-long training on board governance presented by the Kansas Health Foundation, and, along with Karen and Sherri, the school district's 2-day Beyond Diversity training that is required for all school district staff. He is considering sending other leaders to this training, but may work with school district staff to develop a short version for all library staff. He said he has been working with the KU Office of Diversity on a potential work study program to employ students of color at the library for the spring semester. This is still in development. He and Kathleen have developed an IMLS grant proposal for an inclusion internship pilot program to fund a library school student of color. If the program is successful, the foundation might consider funding future internships from unrestricted funds. The 3-year program proposal would fund a year of library school plus providing a part-time work experience here. They plan to work with NEKLS and the School of Information Management at Emporia State University. This project is in the very early stages of development. He said other information is included in the monthly departmental report included in the packet. The board said it was helpful to receive this report.

## Library Foundation Executive Director's Report

Kathleen said the next class in the Foundation's Before You Check Out series, Estate Planning 101, will be presented by Web Golden. There was another successful BFF (Biblio Friends Foundation) event on September 29 featuring Deja Brooks as the guest storyteller. About 90 people attended this after-hours
event with a gain of 70 new Friends members. The Foundation is beginning work on its year end fundraising efforts, including the joint Friends/Foundation letter. The Foundation has received Midco's 2018 computer lab sponsorship of $\$ 15,000$ which will be used to update teen computers; the Foundation will provide matching funds this year. Capitol Federal has pledged $\$ 12,000$ in support of Read Across Lawrence. The Lawrence Journal-World carried an article about the SMART recovery meetings that are being held at the library to provide support to those coping with addictions. The program will be reevaluated in 6 months.

## Friends Report

David said that the fall sale is coming up at end of the month. Last month the Friends gave the library a $\$ 50,000$ payment. The Friends are looking into options for providing reusable bags for patrons of the sale.

## Ongoing Business

Merit Pay Update
Sherri reported on progress on developing a merit pay structure. The board ask that the revised evaluation form be brought back to board by December or January.

## Diversity and Equity Update

Brad said he had covered this in his Director's report. There were no additional questions.

## New Business <br> Review of Kansas Children’s Internet Protection Act Compliance

Every 3 years the board is required to review and approve the library's policy regarding CIPA (Children's Internet Protection Act). This is covered by the library's Internet Access policy, a copy of which was included in the board's packet. Judy moved to approve the policy; Joan seconded. All in favor; motion carried. Brad will report back on how our internet filtering software is updated.

Brady asked if a future agenda item might be to begin looking at longer-term options for library service, such as a city-county system similar to Topeka.

## Adjournment

Brady moved to adjourn the meeting; Joan seconded. All in favor; motion carried. Meeting adjourned at 5:39 p.m.

## Library Director's Report for November 2018

## Meetings About Merit Pay

Sherri and I attended several departmental meetings to share our progress on exploring a merit pay system as well as field any questions or concerns people might have. The most frequently asked question was, "Why are we doing this?" Additionally, many people felt that merit could potentially introduce unnecessary competition and hard feelings among a pretty tight knit, collegial staff. We assured staff that should we move forward with implementation of a merit pay plan, we could do our best to insure fair standards and clear expectations on how to meet standards to qualify for merit pay. Overall, these were very good discussions with staff.

## Another Update on Diversity, Equity, and Inclusion at LPL

We are moving closer to initiating a paid internship program for KU students of color at Lawrence Public Library. Staff at the KU Office of Diversity and Equity are getting everything in order on their end and recruiting potential interns. I will continue to update you as this moves forward in the next couple months. We should be able to achieve internship placements for the spring semester.

Last month, I mentioned that Kathleen submitted a grant application to Institute for Museum and Library Services (IMLS) to seek funding for a pilot project for our inclusive internship idea. Sadly, our application was denied due to a technicality. We filed under the Library Foundation because we already had a grants.gov account for the Foundation, but apparently the library has to make the grant application itself. Despite our appeal for reconsideration, they reaffirmed their denial. Not sure where this leaves us for potential implementation of this project. We plan to submit an application again next year.

## Foundation Director's Report - November 15, 2018

- Elizabeth Schultz Environmental Fund Grant. The Library Foundation has received a \$3,500 grant from Douglas County Community Foundation's Elizabeth Schultz Environmental Fund. The grant will support a visit from award-winning author and environmentalist, Lauret Savoy, author of Trace: Memory, History, Race and the American Landscape. The plan is to have her visit Lawrence in mid-2019. A huge "thank you" goes to Foundation Assistant Logan Isaman who researched, wrote, and submitted the grant to DCCF.
- Book Club Grant. We are delighted to report that Mary and Wint Winter have given the Library Foundation a \$5,000 grant for book club programs at the library. Mary is an avid reader and member of five (yes, you read that correctly!) book clubs. The funds will support expanding the Book Club in a Bag program, including more Kindle bags and "hot" new titles.
- Beach Author Series. The fifth annual Beach Author Series, held on Thursday, November 8th with Nnedi Okorafor, was a great success. Approximately 300 people came out to Liberty Hall on a snowy night for a presentation that focused on her work in comics, as well as writing children's, young adult and adult books. The following morning, Nnedi was in conversation with KU Associate Professor of English Giselle Anatol at the Hall Center to discuss her writing process with students.
- Before You Check Out Class. The Library Foundation hosted "Estate Planning 101" with Web Golden on October $25^{\text {th }}$. This newest class in the Before You Check Out series was a huge success. Approximately 90 people attended this excellent session that provided a clear and understandable outline of what to consider in your estate planning. A special thanks goes to Joan Golden, who was pressed into service setting up chairs and distributing handouts.
- Weave A Tale Workshop. The eighth annual Weave A Tale workshop for librarians took place in Wichita on Wednesday, October $24^{\text {th }}$. The session was held in conjunction with the 2018 Kansas Library Association conference. This annual event is supported by the Library Foundation's Steiner Fund. This year's guest storyteller was Saroj Ghoting, one of the founders of the ALA Every Child Ready to Read program. She gave a wonderful a hands-on session with librarians in the morning and a special storytime for kids and parents at the new Wichita Public Library. NEKLS also provided a grant for this program.
- Kansas Reads to Preschoolers. The Kansas State Library's program, Kansas Reads to Preschoolers, happens November 11-17. Kansas Reads to Preschoolers is an annual event that promotes reading to all Kansas children from birth through age five. The selected book for 2018 is Ten Pigs: An Epic Bath Adventure by Derek Anderson. The Library Foundation's Dr. Bob Fund supported the purchase of 400 copies of the book to give away throughout the week.
